Indigenous cultural landscapes

Management and conservation of values associated with large landscapes



Indigenous Cultural Landscapes are living landscapes to which Indigenous Peoples attribute social, cultural and economic value because of their enduring relationship with the land, water, fauna, flora and spirits and their present and future importance to their cultural identity. An ICL is characterized by features that have been maintained through long-term interactions based on land-care knowledge, and adaptive livelihood practices. They are landscapes over which Indigenous peoples exercise responsibility for stewardship.





- ICLs is a practice that is action oriented (e.g. we want to be able to practice our traditional activities, to make decisions based on our cultures and norms.
- Aboriginal peoples have interacted with and shaped diverse forest landscapes in Canada by creating patterns of resource use based on traditional management systems.
